Installation and Maintenance Guide

Step 1: Prepare the Carpet

Carpeting must be clean and dry before installation.

Step 2: Position the Film

Remove paper release liner to expose adhesive. (Reverse-wound roll has adhesive on outside for easier installation.) Place tacky side down and press the leading 12"–24" of film against the carpet to secure it.

Step 3: Roll It Out

Place roll on floor and push with your foot, "kicking it along" several feet at a time as film unwinds. Repeat until desired length is reached, then cut using scissors or utility knife.

NOTE: On the remaining roll, fold the entire cut end onto itself to create an easy starting point for next application.

Step 4: Finishing Touches

Use hands or feet to smooth entire length of film, pushing any wrinkles or air pockets to the edge. For large areas, protect seams with waterproof tape (not included).

NOTE: Keep liner if not using entire roll; wrap around remaining film to protect adhesive.

ATTENTION: Film can be left in place **up to 4 weeks** depending on conditions and traffic patterns. For longer projects, multiple applications may be required. Any adhesive residue can be cleaned with carpet extractor.

New Pig Adhesive-Backed Mats are not intended for use on wood flooring with stains, finishes, or coatings. If using the Carpet Protection versions of our Adhesive-Backed Mats and Films, please be sure to use only on carpeted surfaces and never on uncarpeted, hard surfaces. New Pig Adhesive-Backed Mats and Films have non-permeable barrier layers to prevent liquid pass-through and though some product construction includes a breathable film layer, may not be suitable for use on surfaces that require air curing, including, but not limited to, newly poured concrete or recently applied coatings, sealants, and finishes. All adhesive mats have some potential to leave residue or lift or discolor finish coatings, paint, and loose or pre-damaged tiles depending on the condition and age of the floors or other surfaces.

For these reasons and others, if you have questions about the suitability of New Pig Adhesive-Backed Mats and Films for your application, test a small section of mat in a discrete or non-critical area before using on larger areas.
