NOTE: Apply message mat, signs and markers to carpeted surfaces only.

Vacuum the base carpet thoroughly to remove dirt and debris so the floor mats/markers will properly adhere. Peel off the backing paper and press into place. Smooth the entire surface to ensure good adhesion.

Cleaning

Vacuum daily, particularly in high-traffic areas, to remove dry soils and debris. (fig. A)

Spot clean spills and stains as they occur.

Deep clean with a rug scrubber or carpet extractor (fig. B) if vacuuming fails to remove stains or grime. Use clean, hot water or the recommended carpet cleaner for your machine. If using a mop, simply wet with clean, hot water and extract the water and soil with a shop vac. Always remove excess water to prevent loosened soils from resettling into the surface.


Removal & Changeouts


Replace when obvious wear is apparent or the bond with base carpet weakens.


To remove mats/markers, peel back a corner and pull up.

To remove a longer runner (fig. C), peel back until you can grasp it with both hands or use the Removal Tool (GRP020) to provide an extra-firm grip. Pull up in a smooth, continuous motion, inching backwards as you go. For long lengths, fold or roll the runner as you remove it.

Deep clean the base carpet before reinstalling.
