6.3. Methods and material for containment and cleaning up

Methods for cleaning up

: Soak up spills with inert solids, such as clay or diatomaceous earth as soon as possible. Collect spillage. Do not flush to sewer. If area of spill is porous, remove as much contaminated earth and gravel, etc. as necessary and place in closed containers for disposal. Store away from other materials.
